ORDINANCE # 2 OF 2023

CALENDAR YEAR 2023 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriations and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the <u>Borough Council</u> of the <u>Borough of Tuckerton</u> in the County of <u>Ocean</u> finds it advisable and necessary to increase its CY 2023 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the <u>Borough Council</u> hereby determines that a <u>1.0</u> % increase in the budget for said year, amounting to \$ <u>40,838.83</u> in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the <u>Borough Council</u> hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriations in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the <u>Borough Council</u> of the <u>Borough of Tuckerton</u>, in the County of <u>Ocean</u>, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the <u>Borough of Tuckerton</u> shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by <u>3.5</u> %, amounting to \$ 142,963.01, and that the CY 2023 municipal budget for the <u>Borough of Tuckerton</u> be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

ORDINANCE #3 OF 2023

ORDINANCE OF THE **BOROUGH** OF TUCKERTON, COUNTY OF OCEAN, STATE OF **NEW** JERSEY. AMENDING AND SUPPLEMENTING CHAPTER 249 **OF** BOROUGH CODE OF THE BOROUGH OF TUCKERTON ENTITLED "WATER AND SEWERS" SO AS TO REVISE THE ANNUAL RATES

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Tuckerton, County of Ocean, and State of New Jersey, as follows,

SECTION 1. Paragraph A of Section 249-34 of the Borough Code of the Borough of Tuckerton entitled "Rates for service charges" is hereby amended and supplemented to read as follows:

§ 249-19. Rates for service charges.

- A. The annual rates for water and sewer service for each year portion thereof furnished by the Borough to its customers for each unit shall be as follows, billable and payable in advance. The minimum rates below will apply whether water and/or sewer service is used, so long as the water and/or sewer service is connected:
 - (1) Basic water rate: \$7.29 per 1,000 gallons of water usage (minimum charge equals 73,000 gallons.)
 - (2) Basic sewer rate: \$11.79 per 1,000 gallons of sewer usage (minimum charge equals 73,000 gallons.)
 - (3) Excess water rate: \$8.50 per 1,000 gallons of water usage in excess of 73,000 gallons.
 - (4) Excess sewer rate: \$12.25 per 1,000 gallons of sewer usage in excess of 73,000 gallons.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for nay reason held invalid of unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

SECTION 4. This ordinance shall take effect after public reading and publication as required by law.

SECTION 1. Section 89-7 of the Borough Code of the Borough of Tuckerton entitled "License Fees" is hereby amended and supplemented to read as follows:

§ 89-7 License Fees

- A. Fees for licenses shall be as follows:
 - (1) Plenary Retail Consumption License, two thousand one hundred forty (\$2,140) dollars
 - (2) Plenary Retail Distribution License, one thousand five hundred twenty four (\$1,524) dollars
 - (3) Club license, one hundred eighty (\$180) dollars

SECTION 2. All ordinances or parts of ordinance inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
