Mr. Martin stated that the Halloween walk at the seaport was a success with over 200 kids that participated. He also stated that the Tuckerton Tree-lighting will take place on Thanksgiving at 7pm at the lake with music and refreshments in the Stewart parking lot. Finally, he stated that Ye Olde Christmas in Tuckerton will be on December 4<sup>th</sup> and a lot of places in Tuckerton are participating and they are still looking for vendors if anyone is interested.

Mr. Martin stated he has reached out to the Ocean County Commissioner's office to get help with the Landyard Lagoon project and now the CFO and Administrator of for the County are looking into it and he is hoping to hear from them this week.

Mr. Martin also stated that the dredging contractor was out doing soundings the last couple weeks and if everything goes to plan, residents should start seeing machinery at the Park by next Monday and the goal is to have the park closed and work to be started around November 18<sup>th</sup>.

Mr. Martin asked Sen. Connors if there was any legislature coming out on dredging and holding the DEP accountable.

Sen. Connors stated that at this time the state is only dredging state navigable waterways. He also stated that there has been legislature passed by the Committee this passed Thursday allowing for Municipalities to put money into a reserve for dredging projects in the future. He stated that it will now go on to the senate to be voted on.

Mrs. Taylor stated that the Tuckerton Environmental Commission had their final Adopt-A-Highway cleanup and thanked all the volunteers for helping. She also stated that the Commission has a lot of great ideas that want to get off the ground and if anyone is interested in helping, their next meeting is this Thursday, November 10 at 7pm.

Mr. Colangelo moved, second by Mr. Vreeland that the meeting be opened to the public.

Ken Hageman, 141 Bass Road, invited everyone to the second annual veteran's memorial on Veteran's Day at 11:11am. He also stated that he and his organization have been very busy the last couple months.

Anne Marie Sweeney, 600 South Green Street, wants an update on the electric charging stations and the marijuana distribution.

Mrs. Taylor stated that the electric charging stations have stalled because the guy they were consulting with to get grants for them has not gotten back to them yet.

Mr. Vreeland stated that he has done some research and that the Council is looking into cannabis distribution.

Beau Borkowski, 9 Carrol Ave, stated that he is new to the area and wants to know what is going on with the fire department and when they will reopen. He stated he just wants to make sure his family is safe.

Mayor Marshall and Mr. D'Amore stated that the situation that is happening with the fire department has been going on for a while and the shared service agreements that were voted on tonight just solidified the aid we have already been using in writing.

Sen. Connors explains why the Borough had to de-designate the Fire Company because of the state's findings.

Mrs. Gleghorn reassured him that all structure fire calls in the Borough, these companies were being called to anyway and that even though it may take them slightly longer to get to a call, they have the state regulated amount of people showing up and are following all the rules.

Kirk Olsen, 228 Western Ave, stated that he got a summons from the construction office for some work being done and believes it is in retaliation for him complaining that they are not doing anything. He also stated that he is still have a continuous problem with his neighbors and he is worried for his daughter's safety and that the code enforcement office and council need to do something. He wants Council to come to his house and see what is going on.

Mr. Martin wants to know what how council going to his house would help?

Mrs. Gleghorn asked him if they have gone to the Court Administrator about this because lawfully there is nothing Council is able to do.

Leanne Olsen, 228 Western Ave, stated that the neighbors are filming her daughters with their drone and wants to know if that is legal. She believes that this situation has gotten very hostile and she does not want to be harassed. She asked if there are any ordinances they are looking into about drones?

Sen. Connors stated that they are looking at other municipal ordinances regarding drones but do not have anything on the agenda as of right now. He and Mrs. Gleghorn also suggested other actions through the legal system they could take with the neighbors.

Mrs. Olsen thanks Sen. Connors and Mrs. Gleghorn for their suggestions.

There being no further comments or questions, Mr. Colangelo moved, second by Mr. Vreeland that the public portion of the meeting be closed. It was so moved.

Mr. Colangelo moved, seconded by Mr. Vreeland that the meeting be adjourned it was unanimously approved at 7:52pm
