

**APRIL 19, 2021**

Mayor Susan R. Marshall called the regular meeting of the Tuckerton Borough Council to order on April 19, 2021 at 7:00 pm in the Borough Complex.

Provisions of the Open Public Meetings Act were complied with as notice was published to the *Beacon* and the *Asbury Park Press* stating the time, date and place of this meeting.

The following members of Council were in attendance: Keith Vreeland, Sam Colangelo, Brian Martin, Frank D'Amore, Suzanne Taylor, Ron Peterson and Mayor Marshall.

Mayor Sue Marshall led the salute to the flag.

Mr. Martin stated there will be an Arbor Day Celebration on April 29, 2021 at the Municipal Complex and this year they will be honoring last year's recipients and this years as well. The recipients are Councilman Mike Santo, Councilman Tony Foglia and Councilman Bill Marshall.

Mr. Martin also explained there will be letters going out for a special assessment on dredging around May 1<sup>st</sup>, the numbers are on the high end, but if the bid comes in under budget there could be a consideration for allowing the contractor to dredge to the original plans, but that will be discussed once we get past the special assessment vote.

Mr. Martin moved, second by Mrs. Taylor that Resolution #89-21, which is the Introduction to the 2021 Municipal Budget, be moved on first reading and schedule the public hearing and adoption of the 2021 budget for May 17, 2021. It was so moved by the unanimous consent of Council.
