Kirk Olsen, 228 Western Ave, stated that he has had personal experiences with neighbors shining lights in to his bedroom and illuminating the house. He stated that he is glad this is finally happening and wants to know when this goes into effect. He also wants to know if Code Enforcement will go out at night to see what is going on and if this pertains to any artificial light. He also wants to know what the Borough will be doing

about the back log of complaints, the process of how to submit a complaint, and what the time frame is to get the code enforcement officer out to the property.

Sen. Connors stated that there is no specified time, however if you come in and make a complaint the code enforcement officer will come out in a reasonable amount of time. If there is an issue where the light has to be measured at specific time, he suggests having a police officer go out to investigate it and will become a witness for the code enforcement officer.

Dawn Mathis, 687 Pine Ave, stated that there is no proof and it's traumatizing for her.

Tarah Busley, 312 Beach Plum Court, asked if this ordinance will also apply to the HOA communities in town.

Sen. Connors stated that yes it will.

Mayor Marshall stated that anyone can get a copy of the ordinance after it is published.

She stated our next Garden Club meeting will be Saturday May 20th, where they will be fixing the beds, weeding and finally planting.

She continued that there next project the club will be working on is the Main Street Planters and would like to thank Hands Garden Center for donating all the plants to beautify the garden.

Mr. Colangelo moved, seconded by Mr. Vreeland to open the meeting to the public. It was so moved.

Dawn Mathis, 687 Pine Ave, stated that she has a problem with her water and sewer billing. She stated that she has gotten different bills and she keeps hearing different things and was told that it is her responsibility to check her bill. She stated she wants her interest waived and wants someone to look into the billing system.

Mayor Marshall asked if she has been in to talk to the tax office.

Mrs. Mathis stated that she has been into the office and they both told her that it is a state law and it's on her.

Kirk Olsen, 228 Western Ave, gives the council pictures of the ongoing problem with his neighbors. He explains that they are screaming expletives at his wife and kids and it is getting worse! Code enforcement is bringing him to court for several violations on his house that his neighbors also have and are not even being looked into. He reported this to Mr. Reed and he was going away, he just wants someone to drive by his house to see what is going on.

Mr. McAndrew stated that he wanted to clarify that his problem is with the construction office and not with code enforcement.

Elain McClure, 199 Cedar Street, stated that she is here speaking on behalf of Nancy Speck. She asked for an update on the fire department.

Sen. Connors explained where Council is at regarding the fire department at the moment.

Paul Solimani, stated that the PCUA meetings have been moved to the Grapevine, and that he submitted a sign drawing for a new and improved Paradise Cove sign.

Mr. Colangelo stated that he should get a tax map and try putting it on private property and not Borough property.

Anthony Scaglione, 125 Curlew Road, thanked Council and Brian Martin and the TBA for finally making way with dredging and landyard lagoon.

Mr. Martin stated that John Schwartz was the one who started all of this and he was just piggy backing off all his work.

Chris Volz, 265 Heron Road, asked if the roads will be paved after the construction on Green Street.

Mr. Colangelo confirmed that they will be paving it.

Kaylyn Ullman, 239 South Green Street, asked if Council had an update on Cannabis.

Mr. Vreeland stated that they have been reviewing it and they are planning to make a statement at the next meeting.

Tarah Busley, 312 Beach Plum Court, stated that she has been having ongoing issues with her HOA and in their bylaws it states that if the HOA cannot fulfill their duties the town can take over the HOA. She also stated that the police are not doing their jobs and someone needs to be held accountable.

Mayor Marshall stated that Council does not get involved in these matters.

There being no further comments or questions, Mr. Colangelo moved, second by Mr. Vreeland that the public portion of the meeting be closed. It was so moved.
