The following people spoke in regards to the dredging in Tuckerton Beach specifically on Flamingo lagoon. Bob Buono, 188 Flamingo Road, Bruce DeRites, 189 Flamingo Road, Pete Gioiello, 358 Kingfisher Road, Jim Davidson, 190 Flamingo Road, Mary Susan Arditi, 203 Heron Road, Anthony Scaglione, 125 Curlew Road, Mike DeFelice, 196 LEH Blvd, and Annamarie DeRites, 189 Flamingo Road.

Mrs. Gleghorn stated that Council will have more information and specific on where they will be dredging after the preconstruction meeting.

JULY 18, 2022

Kirk Olsen, 228 Western Ave, has been having an ongoing issue with his neighbor and has complained multiple times to the construction office about it and they have done nothing about it. He wants to know why they aren't doing anything.

John Zubriski, 707 South Green Street, wants to know why his water and sewer bill keeps increasing and does not believe he uses that much water.

Mrs. Gleghorn, stated that Little Egg Harbor Township charges for how much water they use rather than use a flat rate and excess billing. She also stated that businesses may pay for more than one unit so they are paying more and he is more than welcome to come in and look.

Pete Gioiello, 358 Kingfisher Road, stated that the TBA had a good time with their concert in the park and helped raise money for the Environmental Commission. He also wanted to know if the Borough will have to go out to bid again for the second phase of dredging. Finally he wants to know where the Borough is at with bulkhead violations.

Mrs. Gleghorn stated that she will get him an update on the bulkheads from Mr. McAndrew but warned that most bulkhead contractors are booking a year out due to supply issues.

Carolyn Keen, 84 Curlew Road, commended Jenny on all her help and communication with the public over the last few years. She also wanted to clarify that the vote that was sent out was a curtesy and that Council can decide to do whatever they want. She asked about the 20% rule for change orders and explained what the Borough has been trying to do with Paradise Cove, the West Side of Tuckerton Beach and the East Side of Tuckerton Beach. Finally she wanted to check on the status of the check valves on Curlew because it flooded four times last week.

Mr. Martin stated that it will be cheaper to try and finish the project when the contractor is down there because the machinery will already be there.

Senator Connors, stated that the Borough can surpass the 20% rule by going before the Local Finance Board and asking for a raise.

Mrs. Gleghorn stated that the valves already in, she is just waiting for the public works guys to get trained on them.

Chris Volz, 265 Heron Road, asked where the storm drains down in the beach area go to, because they are overflowing.

Mrs. Gleghorn stated that they go into the marsh.

There being no further comments or questions, Mr. Vreeland moved, second by Mr. Martin that the public portion of the meeting be closed. It was so moved.

Mr. Vreeland moved, second by Mrs. Taylor that the meeting be recessed. So moved.
