Mayor Susan R. Marshall called the regular meeting of the Tuckerton Borough Council to order on September 20, 2021 at 7:00 pm in the Borough Complex.

Provisions of the Open Public Meetings Act were complied with as notice was published to the *Beacon* and the *Asbury Park Press* stating the time, date and place of this meeting.

The following members of Council were in attendance: Keith Vreeland, Brian Martin, Sam Colangelo, Frank D'Amore, Suzanne Taylor, Ron Peterson and Mayor Marshall.

Mayor Marshall led the salute to the flag. She asked for a moment of silence in remembrance of Lily Rose Cramer, daughter of the Borough's employee Charlie Cramer.

### **RESOLUTION #146-21**

#### **RESOLUTION OF THE BOROUGH OF TUCKERTON, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL AN ERRONEOUS TAX BALANCE**

Mrs. Taylor moved, second by Mr. Peterson that Resolution #149-21 be approved as read. It was so moved by the unanimous consent of Council.

Mrs. Taylor stated the Environmental Commission will have a roadway clean up on October 23, 2021 with a rain date of October 24, 2021, Re-Clam the Bay will have a presentation at the next TEC Meeting and the Commission is looking at starting up a subcommittee Garden Club and if anyone is interested to please let the Commission know.

Nedean Maddox, Chairman of the TEC, stated the Commission is adopting plans for the next two to three years that will include safe routes to school, electric car charging stations and the Garden Club that will work with the businesses on Route 9.
