Paul Solimani, 20 Edgewater Drive, stated that the first Paradise Cove Uplander Association meeting will be on February 7, 2023 at 7pm.

He also stated that the Borough should really consider allowing Cannabis and he thinks it would be really good for the town.

Joe Felipe, 92 Edgewater Drive, stated that he has emailed Van Drew to discuss dredging Thompsons's Creek. He wants to know who owns it. His goal is to try and minimize the cost to the Borough but does not believe it will be completely free. He also wants to know what he can do to keep this in motion and to be proactive.

Mr. Martin stated that he believes that the United States Fish and Wildlife Department owns it but is not 100% sure.

Candice Johnson, Jersey Shore Extracts, LLC, stated that she believes Cannabis would help this town greatly. She explains that not only would it bring jobs to the community but it would also bring in revenue from the town. She understands the importance of safety when it comes to children and will compensate by having a security guard. She also stated that if Council does end up allowing Cannabis retail her business would love to get involved in the town such as helping with projects around town like dredging.

Gary Corriero, 925 South Green Street, asked if they will be using the Tuckerton Beach Grill as a cannabis retail location. He asked what the process would be for this to come to fruition because anything to do with cannabis distribution is still in its infancy. He stated that he is also nervous for a cannabis retail store at Tuckerton Beach Grill because it's in the middle of a residential area.

Mr. Vreeland stated that if Council does decide to allow Cannabis it would have to be solidified as an Ordinance as well as go through the Land Use Board where the public will be able to speak on the matter.

Kaylyn Ullman, 239 South Green Street, asked if the ordinance regarding wildlife feeding includes birds and stated Council should keep an open mind when considering the Cannabis.

Mr. Vreeland stated that the ordinance does not include birds.

Carrie Lee Skeie, 381 Heritage Way, stated that the retention basin near her home is attracting a lot of people and it is not advertise to be for public use and since the new construction on Rt. 9 now there is a lot more foot traffic from the main road. She also stated that the emergency vehicle driveway lock keeps getting picked.

There being no further comments or questions, Mr. Colangelo moved, second by Mr. Vreeland that the public portion of the meeting be closed. It was so moved.

Mr. Colangelo moved, second by Mr. Vreeland that the meeting be adjourned. The motion was unanimously approved at 7:41pm.
