Mr. Martin explained he felt it would be very confusing to have an option of yes but which one do you want because the town already voted against the first assessment.

Mrs. Gleghorn stated the town is waiting on the go from the NJIB to fund both projects and once they receive that a bond ordinance will follow.

Carolyn Keen, 84 Curlew Road asked if the town can put on the fact sheet that if the home owner wants to have the lagoon in front of their property dredged they could contact the company doing the project and would need a permit from the NJDEP.

Mrs. Gleghorn explained yes that could happen.

Mrs. Keen than asked if it is possible to have questions for a Council meeting sent in prior to the meeting and the Mayor and Council could answer the questions.

Mayor Marshall stated Mrs. Keen can ask the questions from people who are not in attendance.

MARCH 15, 2021

Peter Gioello, 358 Kingfisher Road, asked how will new FEMA regulations on insurance change the Borough of Tuckerton and the properties located in flood prone areas.

Mrs. Gleghorn stated there is no changes that she is aware of from FEMA that would increase flood insurance, but if he is referring to the CRS designation for a town, the town at one time was designated, but the cost to continue the certification outweighed the actual savings. The town follows all the rules and regulations of a CRS community but we do not pay the State or Federal government fees to have the designation.

There being no comments or questions, Mr. Colangelo moved, second by Mr. Vreeland that the public portion of the meeting be closed. It was so moved.

Mr. Vreeland moved, second by Mr. D'Amore that the meeting be adjourned. The motion was unanimously approved at 8:30 pm.
