Daryl Mercantini, 702 South Green Street, asked why the town does not seek help per se from the back bay areas of Long Beach Island because it is that area that may have cause a lot of filling in of the lagoons on the east side if South Green Street.

John Zubrinski, 707 South Green Street, referenced a post on Facebook that questioned the newly purchased fire truck and what the fire truck would do on standing water in the beach area because the truck sits low to the ground and the Tuckerton Fire Department responded back saying that if there is a need to get to a house in the beach area the fire department could use West Tuckerton's high water truck. Mr. Zubrinski continued that he thought the reason we bought the truck was because the town didn't want to rely on another town, but yet the fire department is making statements like that on Facebook. He also heard that the town is looking to buy another fire truck and wanted to know if that is true.

Mr. D'Amore explained that if there is a matter of saving a life in any area of the town or in the beach area the truck will go through what it has too to save a life, this new truck is a universal truck and can be used for the whole town and there is no plans on buying another fire truck.

Peter Gioello, 358 Kingfisher Road, asked the Council if the assessment will only be a burden on the property owners or will it be a burden on the whole town. He also thanked the Police Department for their assistance with some people and their shenanigans down at South Green Street Park.

It was explained that the assessment is a burden on the property owner only.

Kirk Olsen, 228 Western Avenue, was here to ask for help with the speeding problem on Western Avenue and the parking situation on the same street. It is very dangerous on Western Avenue and should be addressed immediately.

The Chief of Police and the governing body stated they would look into the issue and address the concerns.

There being no further comments or questions, Mr. Colangelo moved, second by Mr. Vreeland that the public portion of the meeting be closed. It was so moved.

Mr. Colangelo moved, second by Mr. Vreeland that the meeting be adjourned. The motion was unanimously approved at 8:03 pm.
