Finally, she also suggested collaborating with a local first responder organization to get training on how to use a defibrillator.

Mrs. Gleghorn stated that she should coordinate with John Bethanis, Public Works Superintendent, to clean out the storage.

Mr. Dupuis stated that the Ocean County Health Department will help with defibrillator training.

Gary Corriero, 929 South Green Street, stated that there is some device down on his street that the county put down there and he wanted to know how long it will be staying, and if it is staying, can they move it back a little because it is blocking people's line of sight when trying to pull on to the street.

Chief Olsen, stated that the county put it down there to monitor flooding and he will see what he can do.

Mr. Martin asked about the turtles this year and wanted to know if anyone needs any help with signs.

Mrs. Ullman, Mrs. Keen, and Mr. Solimani are working on signs.
