Old Business:

The vendors were good, but Mrs. McAndrew mentioned this year she would like to have more. With the uncertainty of the old borough hall a discussion was held as to possible locations for Christmas.

New Business:

Chairwoman McAndrew mentioned Easter is Sunday, April 4, that being said the Tuckerton Easter event will be held on Saturday, April 3rd. The committee discussed Easter activities; maybe businesses have a story book themed tent and give out candy. A discussion about having time slots for kids egg hunt at the ball field, however the committee felt it would be difficult for families with more then one child. The family would come for the event, leave and then have to come back at different times for their other child or children. The committee then talked about having businesses sponsor a table/tent at the ball field and either the business or a volunteer would man the table and give out candy filled plastic eggs. Other suggestions were to have a decorate your funniest Easter hat contest, or decorate your face mask. The committee all agreed to have the Easter event at the ball field and to have some kind of a contest.

Arbor Day is Friday, April 30th. Last year the flag was dedicated to Bill Marshall, his name is on there and then this year we have Mike Santo and Tony Foglia as recipients for this year. There will be a dedication that will be held in the meeting room at borough hall.
