Old Business:

Historic Property Recognition Update: The committee suggested photographing a plaque as an example for ordering new ones, identifying the J.D. Thompson house as the easiest location. The group noted that they have not received any updates from Maureen, expected to follow up last month, and she has yet to make contact.

CLG Application: No updates at this time.

Committee Forum: Ms. Cortiz reported on a recent roundtable with Ocean County historical societies, featuring presentations from Andrea Tingey of the State Historic Preservation Office and Shannon Bremer of the New Jersey Historic Trust on grants available to organizations and

municipalities. She noted that two smaller grants might be useful for local projects and will send the presentations for review. The committee discussed evaluating these grants, determining applicability, and coordinating with the Borough's grant writer to pursue funding, focusing on grants that are feasible and beneficial.

The committee also reviewed Allentown, NJ's historic preservation materials, including minutes, agendas, and COA applications, as models for the Borough. With a population similar to the Borough, Allentown's approach was noted as practical, visually appealing, and appropriate for a town of comparable size and age.
